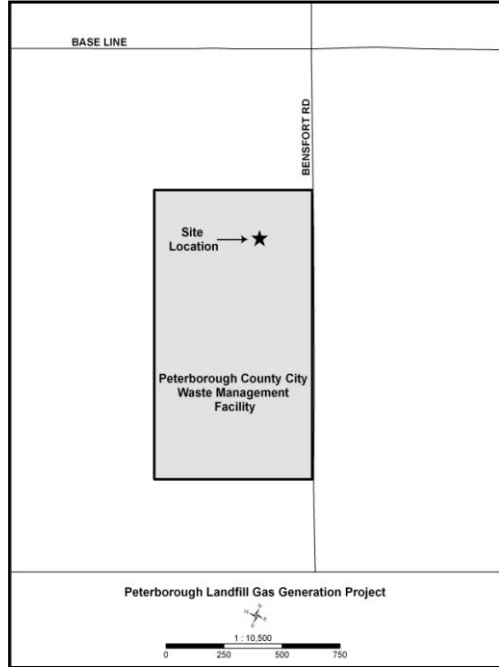
FIRST NOTICE OF SECOND PUBLIC MEETING To be held by Peterborough Utilities Inc. regarding the Peterborough Landfill Gas (LFG) Generation Project

Project Name: Peterborough Landfill Gas (LFG) Generation Project

Project Location: Township of Otonabee-South Monaghan, Peterborough County, Ontario

Dated at: The Township of Otonabee-South Monaghan, this 8th day of April, 2011.

Peterborough Utilities Inc. (PUI) is planning to engage in a renewable energy project which will require the issuance of a renewable energy approval (REA) by the Ministry of Environment. The proposed Landfill Gas (LFG) Generation Project would be located within an existing landfill at 1310 Bensfort Road in the Township of Otonabee-South Monaghan, Peterborough County. PUI has been granted a contract for the sale of electricity from landfill gas with the Ontario Power Authority (OPA) through the Province's Feed-in-Tariff (FIT) program. The distribution of this notice as well as the project itself, are subject to the provisions of the *Environmental Protection Act* (Act) Part V.0.1 and *Ontario Regulation 359/09* (Regulation). This notice is being distributed in accordance with sections 15 & 16 of the Regulation prior to an application being submitted and assessed for completeness by the Ministry of the Environment.



Project Description:

The proposed Landfill Gas Generation Project would have a total name plate capacity of 2.118 MW and has no specific class rating under the Act and Regulation. The project location is outlined in the map provided.
